1. Purpose of Report

1.1 To propose the creation of a non-decision making working group to monitor progress in respect of Oswaldtwistle Theatre and to report to Cabinet in respect of the same

2. Recommendations

2.1 That Cabinet approve the draft terms of reference of the proposed working group attached as an appendix to this report.

3. Reasons for Recommendations and Background

3.1 The Cabinet is committed to progressing the refurbishment of the Oswaldtwistle Civic Theatre which is currently in a poor physical condition and closed to the public. Given public interest in the building, Cabinet is keen to promote wide-ranging dialogue about the future of the Civic, harnessing the enthusiasm of local stakeholders to provide an element of external challenge, ideas and oversight.

3.2 It is therefore proposed that a non-decision making working group is established as proposed in Appendix 1 which would meet four times a year. The working group would be advisory only and would report to Cabinet. The political groups and external organisations would be invited to nominate members of the working group for approval at the next Cabinet meeting. Those nominated will be advised of the requirement to declare conflicts of interest. As the working group will hopefully play a part in shaping

future management arrangements for the Civic, those nominated for membership will be advised that participation in the working group may prevent them bidding to run the Civic (or be involved in its future management) and from bidding for contracts relating to the proposed repair and refurbishment work.

4. **Alternative Options considered and Reasons for Rejection**

- 4.1 Cabinet could decide not to create the proposed working group and to monitor progress in respect of the Civic Theatre via existing arrangements, but this would not bring the element of external oversight and challenge.

- report to Cabinet in respect of the above.
