1. Purpose of Report

- 1.1 *To provide an update on plans for events in Accrington Town Centre for 2025-26 including costs and value of money*

2. Recommendations

- 2.1 That the process remains until such time where new objectives are introduced

3. Reasons for Recommendations and Background

- 3.1 This year's events budget of £150,000 allows for grants to be provided for events taking place in the boroughs high streets, parks and open spaces.

Objectives for these events are;

- Increase visitors to the high street
- Engage with people who live in and around Hyndburn
- Create an event which can engage with the widest possible audience
- Demonstrate value for money
- Explore additional funding sources, other than that of the Council

Objectives met	Increased visitors to the park at Easter. Over 250 children participated in the trail Majority of visitors were Hyndburn residents. Cost per head to the Council £0.60. Additional investment to the event was £150				
Food Festival	Food Festival	Sat 7th June	Accrington town centre	Scott Dawson	£24,000
Objectives Met	An estimated 8,000 visitors attracted to the town centre. Approx. 50% from Hyndburn and the remaining from the wider East Lancashire area. Over 200 new visitors to the town centre. Varied attractions to bring a wider audience to the town centre. Showcased local businesses. Cost per head to the council was £3. Additional investment to the event was £24,000				
Net Zero	Eco Fest	Sat 14th June	Accrington town centre	Prospects	£7,000
Objectives Met	An estimated 9,000 more visitors to the town centre than the previous Eco Fest. Hyndburns own environmental charity raised awareness. Cost to the council was £0.77. Additional investment to the event was £7,000.

Objectives Met	Increased visitors to the park. Over 1200 attendees. Majority of visitors were Hyndburn residents. Cost per head to the council £0.125. Additional investment to the event was £150.

This event will involve 21 venues across three days. The aim of the event is to animate these venues with live music and attract visitors to the town centre and enhance the nighttime economy offering. Each venue will receive an average of £200 investment into attracting visitors. Visitors will receive free entertainment and experience a lively experience in Accrington Town Centre.

This is one of Hyndburn's flagship events which brings around 12,000 visitors from all around the northwest to the town centre. This is one of Accrington's tourism attractions, and was a finalist in last years Lancashire Tourism Awards.

4. **Alternative Options considered and Reasons for Rejection**

- 4.1 Since 2018 we have explored the idea of commissioning a single event organiser to manage the budget and calendar of events. This idea has never been appealing as we find that different types of event attract specific demographics. The mix of events in the town centre currently works, appealing to all.

5. **Consultations**

- 5.1 Since the first consultation event in 2018 we have strived to put on events that were suggested and wanted by the local community and stakeholders. Each event is reported on. We assess how the event has performed in the town centre against our objectives and this assessment helps us make the decision on ¹⁾ whether we repeat it ²⁾ if there needs to be additional activity at the next one and ³⁾ whether there is the appetite for a repeat event.
