RAPE - the victim states that she has been out in IBAR, ACCRINGTON when she has started chatting to a male she does not know. He tells her he has put some cocaine in her drink and she feels a bit "tipsy". They have got a taxi together and gone to his home address. She states that in the living room he has touched her breasts to which she says "NO" and she has backed away

from him into the bedroom. He has pushed her onto the bed where he removes her lower clothing and inserts his finger into her vagina without her consent. She says "NO" and he tries to insert his penis into her vagina. He has then inserted his penis into her mouth. She gets up saying she is going to use the toilet and she leaves the address, going to the nearest shop to contact the police.

Victim has attended SAFE centre for a forensic examination.

CCTV seized at an address across from the suspects premises.

Shop keeper has provided a first account.

ABE1 obtained from the victim and full ABE arranged for 24/06/2019.

Suspect has been arrested and interviewed.
