1. **Purpose of Report**

To seek Council approval to allow the Development Management Development Plan Document (DM DPD) Publication version (Regulation 19 of 'the Regulations'¹) to be publicised for a 6-week consultation period.

2. **Recommendations**

2.1 That Council:

1. receives and notes the minutes of the Cabinet Meeting of 31st August 2016 (paragraph 5.5) in relation to the DM DPD Publication version; and
2. agrees to commence a statutory 6 week public consultation period on the DM DPD Publication Version starting on Thursday 29th September 2016;

3. **Reasons for Recommendations and Background**

3.1 The DM DPD forms an important part of the new Local Plan for Hyndburn. The DM DPD will set out the more detailed planning policies to be used by Development Management Officers and Planning Committee in determining planning applications for the Borough. Once complete, the DM DPD will sit alongside the Core Strategy and

Accrington Area Action Plan, parts of the Local Plan already adopted by the Council (in 2012). It will replace the majority of Local Plan (1996) policies that remain extant².

3.2 The Publication version DM DPD contains 39 policies in total, organised into the following core Chapters:

3.3 The DM DPD also contains ten 'Guidance Notes' which provide further detailed guidance on specific policy matters where required (for example on issues such as affordable housing and shop front design). It also comprises 'Policy Maps' which confirm and identify the spatial extent of key policy constraints referenced within the policies (such as green belt, town centre boundaries etc.).

- 3.4 The Publication version DM DPD supersedes the previous version, the 'Consultation Draft' consulted on in February/March 2016 (further details in the Consultation section below). In addition to amendments arising from representations to the 'Consultation Draft', the Publication version also takes into account relevant findings from new evidence base reports (such as the Council's recently published Retail Study), changes to Government policy and law (such as the introduction of Starter Homes via the Planning and Housing Act 2016), and refinements recommended by a Sustainability Appraisal.
- 3.5 The DM DPD Publication version is in effect the Council's final version of the document, and a statement of intent that it now wishes to submit the document to the Secretary of State ready for examination. In accordance with 'the Regulations', a final 6-week statutory consultation period on this version must now take place, providing individuals and organisations a final opportunity to comment on the 'soundness'³ of the document.
- 3.6 During the statutory 6-week consultation period the following methods of consultation will be used:
- letters/emails will be sent to all contacts on the Local Plans database (approximately 900 people/organisations);
 - copies of the DPD will be deposited in all the Libraries in the Borough;
 - the DPD and all supporting documentation will be available on the Council's website; and
 - press releases and press notices will be sent to local newspapers.

4. Alternative Options considered and Reasons for Rejection

- 4.1 The DM DPD has been prepared in accordance with 'the Regulations'. As the preparation of this document is to be in accordance with this legal framework there are no alternative options for its preparation.

5. Consultations

- 5.1 In accordance with the Regulations, a Consultation Statement will be published alongside the DM DPD. A wide range of people and organisations have been involved in the evolution of the DM DPD up to this point. Three main public consultation events have been undertaken. The first was held in May-June 2012 and the second in Nov-Jan 2013⁴. More recently, a third consultation event was held in Feb-Mar 2016 on the

'Consultation Draft' version of the document. All of this work constitutes 'preparation of a local plan' under the 2012 Regulations.

5.2 A total of 248 separate comments were received during the latest consultation period in Feb/Mar 2016 from 34 individuals/organisations. These comprised comments of support (45), points of objection (63) and general comments (neither clear support nor objection) (140). In June 2016 the Cabinet agreed and approved a formal 'Council Response' to these comments as follows:

- 'Agree – make changes' (94)
- 'Further work required' (84)
- 'Noted' (63)
- 'Disagree – no changes' (7)

The Cabinet report included brief notes against each representation justifying the proposed 'Council Response'.

5.3 As an indication for Members of those individuals/organisations objecting to the 'Consultation Draft', those submitting more than 2 objections included:

- Outdoor Advertising Consultants (20 objections) – specialist advertisement consultancy dealing on behalf of the British Signs and Graphics Association
- Historic England (17 objections)
- JWPC Planning Consultants (4 objections)
- Coal Authority (3 objections)
- Canal and River Trust (3 objections)
- The Wildlife Trust for Lancashire, Manchester and North Merseyside (3 objections)
- Stephen Ward Planning Consultants (3 objections)

5.4 The Publication version therefore incorporates amendments arising from the agreed 'Council Response' and any subsequent discussions held with objecting parties. It also includes amendments arising from new Government Policy and new evidence base reports. The Publication version DM DPD has also been presented and discussed at the Local Plan Member Working Group meetings of the 11th July and 10th August 2016 and Cabinet on the 31st August 2016.

5.5 Cabinet on 31st August resolved to approve the content of the Development Management Development Plan Document Publication Version and for a statutory six week public consultation in the period September/October 2016 to take place. Cabinet also delegated authority to the Council's Executive Director (Legal and Democratic Services) and the Chief Planning and Transportation Officer, following consultation with the Portfolio Holder for Planning, to make further necessary changes to the Development Management Development Plan document as they considered necessary or appropriate, before beginning the public consultation.

- 5.6 In line with the 2012 Regulations the Council is now required to undertake a final statutory consultation period on its Publication version of the DPD providing individuals/organisations with a final opportunity to comment on whether they feel it is 'sound', and meets the relevant legal and procedural requirements.
- 5.7 Following the proposed consultation period (29th September – 10th November 2016) the Council will prepare all relevant documentation to 'Submit' the DM DPD to the Secretary of State and the Examination in Public process begins. Relevant documentation to prepare will include:
- the Publication version DM DPD itself;
 - all representations received on the Publication version;
 - any further proposed changes the Council considers appropriate arising from representations that are made;
 - a Sustainability Appraisal Report;
 - a Consultation Statement; and
 - other such supporting documents that in the opinion of the Local Planning Authority are relevant to the preparation of the DPD
- 5.8 It is anticipated that the Council will have a final adopted DM DPD sometime during 2017 (dependent upon availability of the Planning Inspectorate and the length of the Examination process).

6. **Implications**
